WHEREAS, the Board of Trustees for the Police and Fire Retirement System for the City of Detroit ("Board") is in receipt of an Eligible Domestic Relations Order ("EDRO"), which supplements a Judgment of Divorce entered on January 8, 2016, wherein Alternate Payee DAWN S. LEE-COTTON is awarded certain rights to the retirement benefits of Participant, TONY BARRETT COTTON who is an active employee participating in the Deferred Retirement Option Program ("DROP");

WHEREAS, the EDRO provides that the Alternate Payee DAWN S. LEE-COTTON receive a monthly benefit from the Retirement Allowance portion of Participant's Component I benefit in the amount of 50% of the Participant's Retirement Allowance, which has accrued from August 21, 1999 to January 8, 2016. The EDRO further provides that this applies to any duty disability pension or non-disability pension, and

WHEREAS, the Alternate Payee DAWN S. LEE-COTTON IS entitled to receive a monthly benefit from the Retirement Allowance portion of Participant's Component I benefit in the amount of 50% of the Participant's Retirement Allowance, which has accrued from August 21, 1999 to January 8, 2016, including any duty disability pension or non-duty disability pension, when the Participant is eligible to receive such benefits and as set forth in the EDRO, and SUBJECT TO ALTERNATE PAYEE FILING AN APPLICATION FOR SAME, and

WHEREAS, the EDRO awards the Alternate Payee DAWN S. LEE-COTTON a distribution from the Voluntary Employee Contributions of Participant's Component I benefit account in an amount equal to 50% of the difference between the account balance as of January 8, 2016 and August 21, 1999, including a pro-rata share of any annual adjustments made after January 8, 2016 to reflect gains or losses allocated to the Participant's Voluntary Employee Contributions Account. The EDRO further provides that, if the Participant has an outstanding loan from his Voluntary Employee Contributions Account, the value of the Participant's Voluntary Employee Contributions Account for purposes of the allocation of the shall include any Participant's outstanding loans as of January 8, 2016, and

WHEREAS, the EDRO awards the Alternate Payee **DAWN S. LEE-COTTON** a distribution from the Annuity Savings Fund of Participant's Component II benefit equal to 50% of the difference of the account balance as of January 8, 2016 and August 21, 1999, including a pro-rata share of any annual adjustments made after January 8, 2016 to reflect gains or losses allocated to the Participant's Annuity Savings Fund. The EDRO further provides that, if the Participant has an outstanding loan from his Annuity Savings Fund, the value of the Participant's annuity savings fund for purposes of allocation of assets shall include any Participant's loans outstanding as of January 8, 2016, and

WHEREAS, the Board has been advised by General Counsel that the applicable terms of the EDRO are consistent with the provisions of the Retirement System and applicable law, including Public Act 46 of 1991, MCL 38.1701, *et seq.*, and Public Act 100 of 2002, MCL 38.1681, *et seq.*, as applicable,
