EXECUTIVE DIRECTOR’S REPORT

EXECUTIVE DIRECTOR **CYNTHIA A. THOMAS** PROVIDED THE BOARD WITH A COPY OF AN OCTOBER 31, 2016 MEMO REGARDING THE SYSTEMS’ “HOLD FOR PICK UP” LISTING (RE: RETIREE PENSION CHECKS); NOTING THAT CURRENTLY 35 RETIREES HAVE THEIR CHECKS HELD FOR PICK UP IN THE OFFICE OF THE RETIREMENT SYSTEMS. SHE OPINED THAT IN AN EFFORT TO ELIMINATE THIS PRACTICE, EACH OF THE 35 RETIREES WILL BE NOTIFIED IN WRITING OF THE SYSTEMS’ POLICY THAT EFFECTIVE JANUARY 1, 2017, THEY WILL HAVE SIX (6) MONTHS TO CHOOSE DIRECT DEPOSIT OR THEIR CHECKS WILL BE MAILED TO THEM.
