**WHEREAS**, Exhibit B of the October 17, 2014 Contribution Agreement (“PFRS Governance Terms”) provides that upon the expiration of the term of an Independent Member of the IC, the remaining Independent Member shall make a recommendation to the PRFS Board as to a Successor Independent Member seeking confirmation by the Board of such recommendation, and

**WHEREAS**, the IC recommended the re-appointment of Rebecca S. Sorensen to serve as an Independent Member at its December 12, 2016 IC Meeting. The recommendation was presented to the Board for confirmation at its December 15, 2016 Board Meeting, at which time the Board sought clarification as to the length of the new term for Ms. Sorensen, and
