WHEREAS, the Board of Trustees for the Police and Fire Retirement System for the City of Detroit ("Board") on March 1, 2018, adopted a Resolution approving an Eligible Domestic Relations Order entered on February 8, 2018 ("EDRO") for the above-referenced Participant, and

WHEREAS, this Amended Resolution revises certain details to conform the Resolution with the terms of the EDRO, and

WHEREAS, the Board is in receipt of an EDRO entered on February 8, 2018, which supplements a Judgment of Divorce entered on September 16, 2014, wherein Alternate Payee **VERSHONN J. CLARK** is awarded certain rights to the retirement benefits of Participant **CHARLES V. R. CLARK**, who is a retired employee, and

WHEREAS, the Board has been informed that Participant **CHARLES V. R. CLARK** is a retired employee who is receiving retirement benefits, and

WHEREAS, Participant has attained 20 years of service credit, and

WHEREAS, the EDRO awards the Alternate Payee **VERSHONN J. CLARK** a fifty percent (50%) portion of the Participant's Component I Retirement Allowance, including a pro-rata share of any guaranteed automatic pension increases, which has accrued as of the division date of May 12, 2014, and

WHEREAS, the Alternate Payee **VERSHONN J. CLARK IS** entitled to claim a fifty percent (50%) portion of the Participant's Component I Retirement Allowance as set forth in the EDRO, and

WHEREAS, because the division date of May 12, 2014 precedes the establishment of the Police and Fire Retirement System's Component I Retirement Allowance Plan on July 1, 2014, the Participant had not accrued any Component I Retirement Allowance as of the division date. Therefore, no Component I Retirement Allowance is available as of May 12, 2014 to either the Participant or the Alternate Payee, and whereas consistent with paragraph 10 of the EDRO, the Police and Fire Retirement System is not required to pay any benefit not available under the terms of the Combined Plan.

WHEREAS, the EDRO awards the Alternate Payee **VERSHONN J. CLARK** a fifty percent (50%) portion of the Participant's Component II Pension, including a pro-rata share of any guaranteed automatic pension increases, which has accrued as of the division date of May 12, 2014, and

WHEREAS, the Alternate Payee **VERSHONN J. CLARK IS** entitled to claim a fifty percent (50%) portion of the Participant's Component II Pension as set forth in the EDRO and SUBJECT TO ALTERNATE PAYEE FILING AN APPLICATION FOR SAME, and

WHEREAS, the court order provides for the parties to share the cost of the actuary's fees, and

WHEREAS, the Board has been advised by General Counsel that the applicable terms of said court order are consistent with the provisions of the Retirement System and applicable law, including Public Act 46 of 1991, MCL 38.1701, *et seq.*, and Public Act 100 of 2002, MCL 38.1681, *et seq.*, as applicable,

THEREFORE BE IT RESOLVED, that the Board acknowledges receipt of said court order and shall pay pension benefits consistent with said court order and this resolution SUBJECT TO APPLICATION BEING FILED BY THE PARTY SEEKING PAYMENT, and be it further

RESOLVED, that this file be forwarded to the Board's actuary for calculation of the benefits to be paid to the former spouse, and be it further

RESOLVED, that a copy of this resolution be added to the Participant's pension file, and other appropriate records be kept for the Retirement System relative to this matter, and be it further

RESOLVED, that copies of this resolution be sent to Alternate Payee Vershonn J. Clark and Participant Charles V. R. Clark.
