**FOCUS LIST- OUTPERFORMERS**

**TT International Equity** (Non-US Equity Investment Manager) Developed Markets- Formerly a FocusList Manager for underperformance. TT International has now outperformed its benchmark six of the last seven quarters and outperformed the index by nearly 20% in 2020. TT International ranked top 14<sup>th</sup> percentile of peers over the trailing one-year. (as of 12/31/2020)

**LA Capital Global Equity** (Global Managed Volatility) LA Capital Global Managed Volatility also recently removed from the FocusList of Underperformers has bounced back extremely strong during 2020, outperforming its benchmark by 13.6%. LA Capital's three- and five-year returns are well above its index adding approximately 2.5% value, annually. (as of 12/31/2020)

**Income Research & Management** (Core Fixed Income) Income Research & Management has continued to be a top performer in the Detroit PFRS Core Fixed Income Portfolio. During the 4Q 2020. IR&M outperformed the benchmark by another 0.5% and leads the benchmark by 2.3% in 2020. Longer term performance now ranks near the top 10% of all peers as of December 31, 2020. (as of 12/31/2020)
